Better Group Limited has set a global carbon ambition to be carbon negative in calendar year 2025 and net zero in financial year 2030 (FY2030) with science-based targets set at a global level.

We will update this Carbon Reduction Plan on an annual basis to monitor delivery against plan above.

To give an indication of direction of travel, Better Group Limited will achieve its newly announced carbon negative and net zero targets by:

1. Reducing business travel emissions by 30% by FY2025 against a FY2020 baseline and achieve net zero in FY2030
2. Providing staff with incentives to use renewable energy when working from home
3. Providing Better Group Limited teams with tools that enable them to calculate, then work to reduce the carbon emitted when carrying out client work
4. Using nature-based solutions and carbon-reduction technologies to remove, or offset, more carbon than we emit from the atmosphere each year
